The Board of the Ranches at Pinehurst Property Owners Association believes that there should be a Special assessment to repair the roads in the subdivision.

Whereas the roads were constructed over 20 years ago and exhibit wear and damage due to their usage.

Whereas the Board believes that well maintained roads will enhance the property values in the Ranches.

Whereas the Board believes that road repair costs will rise or be uncertain if the repair period is done over an extended period.

Whereas the estimated repair costs exceed the funds available in the Ranches at Pinehurst reserve account.

Whereas the Board will call a Special Assessment meeting that requires approval of at least 50 percent of the property per the covenants of the Ranches at Pinehurst.

Whereas the Board proposes to spread costs to property owners over a three year period which otherwise maybe higher than many property owners can afford to pay in one assessment.

Therefore the Board will borrow the funds from private lenders and will repay the loan over a three (3) year period starting from the date of approval of the assessment and that all funds collected from the assessment will be used solely to pay for the road repairs and the investors. The Board will call the Special Assessment meeting for June 13, 2024.
